### Mission Statement

Catholic Missions In Canada exists to keep the Catholic Faith in remote and poor mission communities across Canada.

Through the raising of funds by various financial vehicles, CMIC administrates and manages donations for allocation to projects in, mostly, isolated or remote areas of Canada's Northern dioceses of Catholic bishops who need support for missionary activities. Funds are also used in a bourse for the education of seminarians. To date, 24 dioceses, archdiocese, and eparchies receive our funding.

### Our History

On September 23, 1908, Monsignor E. Alfred Burke from the Diocese of Charlottetown, Prince Edward Island, founded "The Catholic Church Extension Society of Canada," to raise funds to help "cultivate the missionary spirit in the clergy and the people," and "to preserve the Faith of Jesus Christ among Catholic immigrants" then resettling in the Canadian West. Pope Pius X, on June 9, 1910, issued a charter to the Society for "the protection and diffusion and the preservation of the Catholic Faith in the territories of the Dominion of Canada." In 1999, the name of the Society was changed to Catholic Missions In Canada to better reflect its mission and outreach.

### Our Board Of Governors

Catholic Missions In Canada is directed by its Board of Governors which ensures that the organization operates according to its guidelines and by-laws. The Board consists of: the Apostolic Chancellor, who is always the Archbishop of Toronto; seven bishops from across Canada; and five Catholic lay persons. The Board meets at least annually to scrutinize the work and the progress of the Catholic Missions in Canada staff, and make proposals and recommendations.
